Hemos comprobado que ese monedero todavía está vacío en el enlace <https://www.blockchain.com/btc/address/ca1f9f30b0cba98092e0eadb758d101335d54cb5?sort=0>

APEDANICA se ofrece a todos los que hayan recibido mensajes parecidos para agotar todas las posibilidades legales de identificación de extorsionadores en cualquier país, haciendo responsables civiles a todos los que aportan algún elemento útil para su extorsión. Tenemos algunas **hipótesis periciales que preferimos no publicar todavía.**

APEDANICA solicita audiencia con el fiscal más competente para la investigación de lo que se conoce como “**SEXTORTION**” o **PORN BLACKMAIL SCAM** porque estamos desarrollando contramedidas y tecnologías que evidencien pericialmente que existen organizaciones criminales internacionales que envían mensajes como el delictivo que adjuntamos suprimiendo, únicamente, los datos de quien nos ha confiado su problema (para quien pedimos la máxima protección legal).

It is just so unfortunate. I do know P1 is your password. More importantly, I do know about your secret and I've evidence of this. You don't know me personally and nobody hired me to examine you.

It is just your misfortune that I came across your misdemeanor. The truth is, I actually setup a malware on the adult videos (sexually graphic) and you visited this website to have fun (you know what I mean). When you were busy watching video clips, your browser began working as a Rdp (Remote control desktop) with a key logger which provided me with accessibility to your screen and webcam. Just after that, my software gathered all your contacts from facebook, and mailbox.

After that I put in much more hours than I probably should've looking into your life and created a two view video. First part shows the video you had been watching and next part displays the view from your webcam (its you doing nasty things).

Frankly, I'm ready to forget everything about you and let you continue with your life. And I am about to provide you two options which will accomplish that. These two choices to either ignore this letter, or simply just pay me \$7000. Let's explore those 2 options in details.

Expalin no-one what you will be sending the bitcoin for or they possibly will not sell it to you. The method to obtain bitcoins may take a few days so do not wait.

I have a special pixel within this mail, and at this moment I know that you've read this e-mail. You have 2 days to make the payment. If I don't receive the BitCoin, I will send your video recording to your entire contacts including friends and family, colleagues, and so on. You better come up with an excuse for friends and family before they find out. Nevertheless, if I receive the payment, I will erase the recording and all other proofs immediately. It's a non negotiable one time offer, so please don't ruin my personal time & yours. Your time is running out. Please note that, my malware will still be sharing what action you adopt when you're done looking over this message. To be honest, If I see any wrong activity from your search history then I will send your video recording to your relatives, coworkers before time ends.
